

**ST. JOHN THE BAPTIST PARISH SCHOOL BOARD AFFIDAVIT
(BY PARENT/GUARDIAN VERIFYING STUDENT RESIDENCE)**

A parent/guardian who is residing with a friend or relative on a temporary or permanent basis must complete the official St. John the Baptist Parish School Board Affidavit of Place of Residence document.

The PARENT/GUARDIAN must provide a valid driver's license or state ID with a current address and a recent utility bill (Electric or Gas Only!) or voter registration card which includes a physical address.

If the school has reason to believe that information in the Affidavit is incorrect, and the student is residing outside of the school district, an investigation to determine residency will be conducted by the St. John the Baptist Parish School Board. St. John the Baptist Parish students will be returned to the school in the district where they reside. Out of parish students will be withdrawn immediately from the school.

Residency Affidavits must be resubmitted for approval at the beginning of each new academic school year.
